# HALL RENTAL AGREEMENT

- 1. Rental Fee is \$125.00 with a \$50.00 deposit, which shall be refunded after the hall has been inspected. We are requesting that you provide two separate checks in these amounts. The \$50.00 deposit will be destroyed after the hall has been inspected for any violations that may have occurred during your rental. Please make both checks out to Chicora Independent Hose Company. A \$30.00 fee will be charged for any returned check. Maximum capacity of the hall is 90 people.
- 2. The individual that is renting the hall must be 21
- 3. ALCOHOLIC BEVERAGES ARE STRICTLY THE RESPONSIBILITY OF THE INDIVIDUAL RENTING THE HALL, NO ONE UNDER THE AGE OF 21 MAY CONSUME ALCOHOLIC BEVERAGES.
- 4. Your event must end by 11:00 pm and everyone must be out of the hall by 11:30
- 5. When renting the hall, the truck garage is strictly off limits
- 6. Parking is only permitted across the street in the lot marked "Fire Dept use only." Handicapped parking is available where marked on the paved area near the main Entrance. Absolutely No parking in front of any garage door at the CIHC is permitted at any time.
- 7. Parking is permitted in front of the Post Office on Sundays and after 12:00PM on Saturdays. **Absolutely No Parking** is permitted in and around the loading dock area of the Post Office.
- 8. Responsibility for the hall is to be assumed by the individual whose signature is on the agreement. This person will be held liable for any and all damage, abuse or misuse of CHIC property. Cost for reimbursement will be determined by the officers of CIHC.
- 9. Paper plates, cups, napkins, silverware, foil, plastic wrap, trash bags, dish soap, paper towels, dishcloths, are to be provided by the individual or group renting the hall. Our coffee pots may be used but must be washed, dried properly and put away after use. All drink dispensers must be kept in the kitchen area off of the carpet. We have (11) 5-ft round tables and approximately (7) 6-ft rectangle tables for your use.

11. Restrooms must be kept clean and free of debris.

- 12. DO NOT use tape, tacks, nails etc. on any surfaces
- 13. Keep all windows and doors closed when the heating or air conditioning is on.
- 14. The CIHC has the right to reject any individual or group wanting to rent the hall.
- 15. The CIHC has the right to cancel any rental due to any emergency situation that may arise, the rental fee will be returned to the renter who signed the contract.
- 16. When your activity is finished all areas must be left in the same neatly organized condition that it was found. All trash and waste are to be disposed of in the trash cans. All trash must be taken to the dumpster in the rear of the building. Counters and table tops must be wiped down and free from any spills etc. Floors will be swept with the sweeper in the storage closet. If anything has been spilled on the floor or carpeted area please use a wet rag or a mop to clean it up. Tables and chairs must be returned to the original positions when complete.
- 17. By signing this contract, you are acknowledging that you and your party will follow all current CDC recommendations for indoor events, social distancing and face coverings. The CIHC shall not be held responsible for any violations for above mentioned CDC recommended guidelines.
